I understand that it may be necessary to limit the number of children supervised at any one time. Drop-in care may not be available due to safety restrictions. Pre-registered families with confirmations are guaranteed space.

During hours of care, parents must be in the building and available for paging.

We cannot accept children who are ill. If your child should become ill, you will be paged to pick him/her up.

Parents need to arrange meals for their children through pre-registration or by picking him/her up at mealtime if he/she has been accepted for drop in care that day.

If childcare is the responsibility of the parent, payment for childcare is due daily and, rounded to the nearest half hour. Care is available only during the listed hours of operation. We accept cash, traveler's checks as well as Discover, Visa, and MasterCard (Novus credit cards).

Check-in security procedures are to be followed for a smooth, safe operation of the center. Failure to follow center rules will result in loss of confirmation of space or acceptance of your child for care.
