The April Meeting will be held at the Monsanto – Muscatine Plant. The Muscatine plant employs 480 full-time Monsanto personnel. It started as an ammonia terminal in 1961. Monsanto owns 550 acres at the Muscatine plant: 146 acres are developed, 90 acres are part of a nature preserve, and 100 acres are sand prairie. Acetanilide and glyphosate based herbicides are produced at the Muscatine plant.

Monsanto has graciously offered to provide us with pizza and sodas for dinner. Dress requirements are closed-toe shoes, shirt with sleeves (no tank tops), pants or slacks (no shorts or skirts). Monsanto will provide safety glasses, hardhats, and gloves (if necessary). Katharine Larsen, Christy McGuire, and Rose Ayres at Monsanto are planning the April meeting. Directions to the Monsanto Muscatine Plant:

Take US 61S toward Muscatine.

The motels and restaurants are at the northeast end of Muscatine near the intersection of US 61, business 61 and IA 38. From that intersection stay on 61 south which takes you around Muscatine.

At the south end of town where 61 and 92 turn right, **Don't turn right**. Stay in the center lane and continue straight ahead on the Industrial Connector, which serves the plants in that area.

At the next intersection turn right on Stewart Road.

After 3 miles, at the flashing amber light, angle left on Ogilvie. After a ¼ mile, turn left again on Wiggins Road. This brings you to Monsanto. Go past the trailer drop lot, the Ag-E parking lot, and use the second entrance to the employee parking lot. There is a Visitors parking lot near the receptionist's office.
